"Commercially available data" - information to the Norwegian Petroleum Directorate pursuant to Section 85, fourth subsection of the Petroleum Regulations, cf. Section 6, eighth subsection

In the event of survey activity in accordance with an exploration and/or production licence, pursuant to Section 85, fourth subsection of the Petroleum Regulations, the licensee must inform the Norwegian Petroleum Directorate (NPD) as to whether the data from a survey is commercially available or not. It also emerges from the same provision that the NPD can determine what is considered commercially available data. The distinction is mainly significant for the length of the duty of secrecy pursuant to Section 85, second subsection of the Petroleum Regulations.

Section 6, eighth subsection of the Petroleum Regulations stipulates requirements for reporting data from an exploration activity within an indicated deadline. The reporting must indicate whether the results from the survey should be commercially available (Section 6, eighth subsection of the Regulations).

Currently, information on the category "commercial availability" is reported at the same time as the survey is reported (5 weeks before start-up). In practice, this takes place by the information being entered into the NPD's electronic notification system (Section 4, No. 1, litera p of the Resource Management Regulations) together with other information. Here, one confirms whether the data should be commercially available or not.

The authorities have assessed whether the regulations have functioned according to their intention and have concluded that they will not amend the regulations in this case. However, they see the need to clarify the commercial availability requirement, and that licensees who normally do not acquire data for the purpose of further sale must document the basis for reporting that a survey is "commercially available".

Commercially available data will be data that is only acquired for the purpose of submitting the data for sale to a third party. It is a precondition that the data <u>must be</u> commercially available from the time when they are available to the owner. This means that the data must be available for everyone at market price from when the data are available to the owner and

ready for use. Data acquired for internal use in one or more production licences are not considered "commercially available".

Licensees who do not normally carry out surveys with the purpose of selling the data, must document their basis for reporting a survey as commercially available at the same time as they report data pursuant to Section 6, eighth subsection of the Petroleum Regulations, cf. the final subsection.
